# THE EARTH HOUSE

### INTRODUCTION

The Earth House project has been present for a long time. Its particular relevance is very actual at the occasion of the conference Globalism vs. Nationalism.

This project is not seen as an alternative to creating a World government or to a reforming the UN, but it is seen as something new, built on experience and conclusions made from the mistakes of the past generations. The project is an attempt to give answers to the vital problems of humanity. For a long time in the past the Future has been considered to be better than contemporary world.

What has been learned by analyzing the development of the World since 1972, when the first UN conference on the Human environment took place in Stockholm? "Yesterday's future" has been a time of great challenges, missunderstandings and problems. By UN's goals of sustainable development, today, we strive for much better world and prosperity.

Related to the Goals the key word is "development". Those who try to plan the Future obviously have problems with Responsibility! It is the responsibility for the Debts, for the developed, for the democracy, the process which often leads to wars on national and religious soil.

At the beginning of the millennium in 2001 the world celebrated, for the first time, the World Day of Planetary Consciousness, initiated by the Budapest Club followed by events in Kiev and St. Petersburg when the idea "Think globally — act locally and Responsibly" was proposed. There was a feeling that the World is entering to millennium together and with a renewed consciousness.

## THE HOUSE OF EARTH

There are quite a lot of models and theories of building the Future in the World, one of which is the project of Venus Jacques Fresco. All of these scenarios confirm

that it is hard time to recognize that a question of Future of Earth has become the most actual subject, not any science fiction.

The action of "combining efforts to preserve the Future" is the fundament of idea of establishing the Earth House: 6 components — 6 continents — 6 parts of the Earth House. In this a way the House exists in our Planetary consciousness!

The content and purpose of such construction is the preservation of the Planet for the Future, the creation of institutions working on the problems of the Future and giving the vector development of mankind.

It is obvious that the "Business as usual" led mankind into a dead end. Each of the past civilizations went through a value inversion associated with the notion of the impermanence of power, the falsity of the imperative of domination.

Today we propose to build a House that will unite sound and progressive forces aiming to preserve the Future of, and on the Earth.

There have been, already, attempts to build similar houses. For example, there is a House for Nations — UN building. There are too many interests and contradictions in the UN. What did this give to the world? Of course, a lot! But the wars continue, inequality is bigger, poverty is increasing most often because of the nation's assertion of its "right of nations to self-determination".

The beginning of the millennium have given us an understanding of human problems, the understanding that Mankind could have no the Future.

Beyond the UN sustainable development goals there are the Goals for states, used by them to continue to self-define their interests (the main UN principle) what often creates threats and conflicts.

Earth is our common House!

But, for the challenges facing humanity, it is necessary not just a new building, but it is necessary a new planetary Vision, Consciousness, Understanding, Ethics. For those reasons there is need for a new Planetary Architecture. The necessary new Planetary Policy! This ought to be building with a decentralized system of self-government. Planetary Architecture will help develop the Planetary Policy! Such building should be designed in the form of a ball, which consists of 6 segments, which are installed on different continents.

All six segments of such buildings, regional centers, placed in the space of the Earth form a round room of meetings.

One should not need to travel from continent to continent. The world can unite around achieving the goals of sustainable development such to survive! It should strive towards the objectives of sustainable development!

We propose to build a "Earth House" for the UN's Sustainable Development Goals for the whole world.

The Earth House is the Unification Symbol on new principles, aiming to achieve common goals.

The Earth House is a space for creating a system of "NEW SMART GLOB-AL SELF-GOVERNMENT" (SGSG) in the interests of balanced and sustainable development.

The citizens of the World should build the EARTH HOUSE together and even on the principles of KRAUDFANDING.




Fig. 1 Earth House — 6 continents — 6 parts of the Earth House.

The highest goal of humanity — the preservation of Earth civilization — can be achieved solely through the transformation by a fundamentally new type of managed civilization, a fundamentally new human with a completely new worldviews.

A worldview -revolutionary transformation of the Earth's civilization will be extraordinarily difficult, but humanity must do it.

A model of a controlled world, or model of an Earthly controlled civilization, is described by a system of generalized parameters.

Unlike the two-element (biosphere-humanity) model of the ungovernable world (Meadows, Горшков) globalists proposed a fundamentally new model consisting of three elements: the biosphere, the countries of the world as a whole, and a single country. Interactions between the elements of the model are described by four generalized, quantitative parameters: the anthropogenic load index, the development stability index, the rental number (rent), and the social and economic disharmony index of society. The first effectively controlled parameter is the rent, which will be levied from countries for using the biosphere. Rental money will go to preserve the nature of the planet. Rent numbers on a 100-point scale are calculated for all countries of the world.

Furthermore, globalists have introduced two quantitative criteria into, the concept of the noosphere and sustainable development of society. For the noosphere and sustainable development, the criteria are identical. The criteria are as follows:

The interaction between all mankind and the entire biosphere of the Earth will be harmonious if the power density of the anthropogenic pressure does not exceed approximately 70 kW/km. The permissible value of the power density is taken as the average, given by the resource model of the Meadows world and the Горшков biosphere model. At present, this real density is 1.5–2.0 times more than the permissible value.

In addition the interactions within the world society will be harmonious if the index of socio-economic disharmony of society will not exceed 10–15.

The admissible value of the index of disharmony of the World society is taken equal to the average value of the indices for the countries of the World. At present, this index, for the World as a whole, is increasing, approaching 100. It is to be emphasized that this index is a measure not only of widening the gap between rich and poor countries, but also a measure of international terrorism, drug trafficking, corruption, military and religious conflicts, collisions of civilizations, and of the degradation of culture and personality.

Both criteria must be fulfilled. To fulfill the first criterion, one must the first work on the implementation of the second criterion. The world society full of internal contradictories and conflicts, in principle, can neither achieve sustainable development, nor come to the noosphere, nor create an controlled civilization on the Earth.

The global management of the controlled civilization on the Earth is the process of organizing the life activity such to ensures the harmonious interaction of mankind and the biosphere, as well as harmonious interactions within the world community, which in turn are regulated by the non-rising power density of the anthropogenic load of 70 kW/km 2 and the socio-economic disharmony index of the world society being 10–15 respectively.

Humanity has come to the dead end point — a global catastrophe. Urgent actions of a giant scale are needed in a modern, transcendental world which is going to a global catastrophe. The globalization is the primary methodological approach, and a policy based on globalism is secondary.

On the basis of the regional centers for coordination and cooperation of the Earth House it will be created a global system for monitoring and neutralizing threats to humanity, which will contribute to the growth of people's well-being in different parts of the world, and help support the overall strategic balance in the world such to achieve sustainability.

### CONCLUSIONS

We are convinced that the UN should continue to play a central role in the many world agenda. But, at the same time, it is only possible through the development of a regional networks to resolve or concentrate, and do research the world-wide challenges.

Such a partnership networks will help to avoid unnecessary duplication, such to act in the common interests of our civilization without creating exclusive clubs, the world elite, dividing lines and world governments in shadow.

In addition, it is believed that the Regional Centers for Cooperation of the Earth House should not be limited to scientific research and recommendations, but, at the same time, to the extensive cultural contacts, the dialogue of academic circles and politicians, governments, the exchange of cadres in solving global problems of the present
